CHAIR'S REPORT FOR 2022

BICF HISTORICAL BACKGROUND:

The BICF was incorporated as a Society in 2001 and obtained charitable status in 2003. Its membership is composed of an all-volunteer Board. The Foundation helps build a resilient Community to strengthen Bowen Islanders' sense of belonging. We do this by encouraging individual and organizational engagement in our Community through philanthropy. Our Annual Giving campaign is "Community Grows Here."

The Foundation is one of approximately 200 Community Foundations in Canada and draws investment expertise from the Vancouver Foundation.

Our mission is to engage the community and inspire generosity that will benefit Bowen Island for generations, to realize our vision of an enriched quality of life for all Bowen Islanders.

THE YEAR IN REVIEW:

Thankfully, during 2022, the restrictions experienced in previous years because of the pandemic, were slowly being lifted. This has enabled us to enjoy meeting in person once again and Bowen has continued to be as generous and giving a community in 2022 as it was during the difficult pandemic years.

During 2022, the Foundation was the recipient of an incredibly generous level of giving which led to a total of \$238, 864. This was very close to the previous year's total of \$245,242, both of which were remarkable in the context of the pandemic and the many other worthwhile charitable fundraising projects occurring on Bowen.

The end of 2022 brought the combined market value of our funds held at the First Credit Union, and endowed with the Vancouver Foundation to \$2,803,692, a slight increase on the previous year's total of \$2,799,525. This includes a very generous donation to the Community Centre that the Foundation is stewarding until the time it is required by the Community Centre.

We continued our yearly granting cycles, giving out \$112, 292, combined from our larger Community Impact Grants, the individual \$500 Neighbourhood Small Grants, the many Scholarships & Bursaries, the Youth at Risk Fund and Helping Hand Fund. In 2022, thanks to Bowen's generous donors and our investment income, the Foundation was able to raise the maximum amount of an individual Community Impact Grant from \$15,000 to \$25,000. At the same time, recognising that many community projects have small beginnings, the minimum grant remains at \$2500.

In addition, during 2022, the generosity of an anonymous Bowen Islander established the Brian Biddlecombe Memorial award, a new endowment fund that will provide an annual award for Bowen's Volunteer Fire Department and their immediate families to pursue post-secondary education or vocational training. Also set up since the last



Annual Meeting, is a new Endowment Fund by Island Pacific School which will provide bursaries for students to attend IPS. This is in addition to the Marg Witty Bursary Fund for IPS students set up in Marg's memory by Dave Witty.

All of this work in 2022 is the result of the commitment of each of the Foundation's volunteer Board. I want to acknowledge that commitment as well as the breadth of knowledge and experience that makes it a pleasure to work alongside Board colleagues to fulfil the mission of the Community Foundation. Last year, at the time of the Annual Meeting, we said goodbye to Joanne Gassman, Neil Boyd and Jen Hall, all long serving Directors. Holly Graff, who continued as Chair in 2022, paid deserved and fulsome tribute to their many contributions to the Foundation in her Chair's report last year. Amanda Ockeloen also stepped back from her Board Director position later in 2022 although has continued in her much-valued role on the Helping Hand Committee. We are grateful to all these Directors who have continued to serve the Bowen community through the Foundation's work.

This year, we are saying goodbye to our Chair, Holly Graff. I want to pay tribute to Holly for all the work she has undertaken as a Director since 2017 and Board Chair since 2019. We thank her for her knowledgeable and inspirational leadership of the Board and her unwavering commitment to serving the Bowen Island community through the work of the Foundation with grace and good humour. The Foundation, its donors and recipients have been in very safe hands for the last four years. Holly leaves big shoes to fill and I am so pleased that she will continue for a year as a non-voting Board member as Past Chair.

As a volunteer Board, being able to rely on an Administrator is crucial to getting the work done. In 2022, we said goodbye to our previous wonderful Administrator, Lisa Wrinch but we were also lucky enough to find our current Administrator, Martina Iring who has stepped, seemingly seamlessly, into the role. Thank you Martina; the Board honestly couldn't do what we do without you and your amazing skills.

We have also been lucky to find two new Board members this year and welcome Gayle Farrell and Greg Gibson along with their considerable skills and knowledge. Gayle has amassed a wide range and depth of skills in working with multiple stakeholders in strategic and operational planning and now runs her own consulting company. She also has considerable experience of the not-for-profit sector, both in her employment history and in her volunteering. Greg has a background in arts and culture and is currently the undergraduate advisor and academic administrator in the Department of Art History, Visual Art and Theory at UBC, previously having worked in the arts-focused publishing field. Greg also has experience in a not-for-profit organisation providing loans to support economic empowerment. Thank you both for your interest in and commitment to the Foundation and we look forward to working with you over the years of your term of office.

It is the case that when you join the work of the Community Foundation, you never really leave it and so I want to say a big thank you to all those who, having served on the Board, then continue to serve as volunteers on Committees or in mentoring new Chairs. To our other Committee volunteers supporting the work of the Foundation and to our many donors, grateful thanks. I am proud to be a part of the Foundation's work and to serve as its Chair for 2023.
