# Bequests and sample wording

The charitable bequest in your Will can provide a specific dollar amount, a percentage of your Estate, or a gift of the residue, which consists of whatever remains in your Estate after gifts to your loved ones and all expenses have been paid.

Unless otherwise directed, all Estate gifts to the Bowen Island Community Foundation of \$10,000 or more will be used to establish a permanent endowment fund in honour of the donor. The Foundation will invest your donation wisely, and grant the annual income disbursements to charities in accordance to your wishes.
